Russian Mob Running Prostitution

According to the FBI, there are over 200 Russian mobs operating in American, in at least 17 cities in 14 states. At least four of those groups operate in California alone, with interests in **Los Angeles**, San Francisco, San Jose, Sacramento, and San Diego.
