Baseline Standards for University Recognition

The University of Oregon has established a set of baseline standards that must be maintained by all fraternities and sororities. Fraternities and sororities that fail to meet these standards will not be recognized by the University. Fraternities and sororities that are not recognized by the University may not receive University support, privileges or other benefits. The baseline standards Fraternities and sororities are required to abide by include the following:

1. Chapter Requirements

- a. Maintain chapter documentation with the Director of Fraternity & Sorority Life, including:
 - i. Member roster (submitted each term)
 - ii. New Member Grade Release Form (submitted with each new member class)
 - iii. Officer and Advisor roster (submitted annually after chapter elections)
 - iv. Signed Anti-Hazing Policy (submitted annually after chapter elections)
 - v. New Member Education calendar
 - vi. Updated chapter bylaws and constitution (submitted annually)
 - vii. Chapter Risk Management Policy (submitted annually)
- b. Have an chapter advisory/corporation board
- c. Chapter GPA must be one of the following (avg. 3 terms – winter/spring/fall):
 - i. at or above the all men's/all women's average
 - ii. 3.0 or higher
 - iii. show improvement from the last review
- d. Abide by all local, state and federal laws, the UO Student Code of Conduct, the IFC and PHC Constitutions and Bylaws, any additional council policies and procedures.
- e. Mandatory attendance of at least 85% of new members at FSL New Member Orientation
- f. If Housed:
 - i. Employ Resident Advisor
 - ii. Facility is alcohol and substance free
 - iii. Participate in Fire and Health Safety Program, which includes:
 1. Passing an annual fire inspection (documentation provided annually)
 2. Passing an annual health inspection
 3. Owned facilities must have fire suppression systems (sprinklers)

2. Chapter President Requirements

- a. Must attend the FSL *Greek Leadership Academy* held in January each year
- b. Schedule and attend a quarterly one-on-one meeting with FSL staff

Chapters not abiding by these requirements may lose recognition from the University of Oregon. For a list of the benefits of recognition, please see the Fraternity and Sorority Life website. Chapter recognition will be evaluated on an annual basis at the start of each spring term. Performance by the chapter during the previous three terms will be taken into account.
